Blood Lead Registry Service

The Centers for Disease Control and Prevention (CDC) applies nationally consistent standard definitions and classifications for blood lead surveillance data from all states. The purpose of the Blood Lead Registry is to provide providers with the information necessary to determine whether a child should be tested for blood lead. Without a registry, this information is often not otherwise available or easily accessible.

The Blood Lead Registry is built on the Wisconsin Immunization Registry, a State of Wisconsin licensed application available for customization.
