



Re: DC Medicaid – Fiscal Agent Transition Summary

Dear Provider Community,

We would like to inform you that the original go-live date, previously scheduled for December 1, 2025, has been rescheduled to March 2, 2026. This adjustment has been made to ensure a smooth and successful transition, allowing us to complete all necessary preparations and validations.

Effective March 2, 2026, fiscal agent services will transition to Gainwell. Before submitting any claims, providers must register as a trading partner and complete certification to submit electronic claims through Gainwell's provider portal. This change is applicable only to providers who submit fee-for-service claims to DC Medicaid through Conduent.

If you are not the registered billing agent, please kindly forward this information to the appropriate person or department as soon as possible to avoid any delays.

## **Upcoming:**

• January 6, 2026: Provider training available.

- January 14 20, 2026: You will receive Web Portal registration instructions with a temporary Provider Identification Number (PIN) to establish a new Trading Partner ID and login credentials.
- January 20, 2026: Provider web portal at <a href="https://medicaid.dc.gov">https://medicaid.dc.gov</a> opens for available documentation and companion guides to be downloaded. Support for EDI registration and questions via email may be sent to <a href="https://decimegainwelltechnologies.com">dcedi@gainwelltechnologies.com</a> beginning on this date.
- February 2, 2026: Provider web portal at <a href="https://medicaid.dc.gov">https://medicaid.dc.gov</a> opens for providers and billing agents' registration. If you plan to submit electronic claims directly to the new DC MMIS, after portal registration, you will receive a one-time system certification notice after testing. You may register after February 2, 2026, and before you begin submitting claims on March 1, 2026. Contact center support will be available on February 2, 2026, by calling (844) 366-4237.
- March 2, 2026: Gainwell begins full fiscal agent services and receipt of DC Medicaid fee-for-service claims. If you are a provider with one of DHCF's Managed Care Plans (MCPs), there is no change for you, and you will continue to bill with the MCPs.

This phased approach allows you to register and verify your ability to submit X12 transactions and receive responses through the new provider portal.

## **Benefits of the Upcoming Transition**

The new DC Provider Portal will continue to offer a range of features, including the ability to:

- Submit electronic or direct entry claims
- Check claim status and payments
- View beneficiary eligibility and history
- Download 835s
- Register as a trading partner
